

# ARTS, CRAFTS, & COLLECTIBLES SHOW



## Eligibility

This show is open to anyone 18 years of age or older, whose craft work reflects original design and quality execution, and for those with collectibles such as antiques, coins, comic books, dolls and stamps. No other vendors besides those with arts, crafts and collectibles will be able to participate in the show. At least three (3) photos must accompany each application and must be a representative of all items intended for sale and display. Please use high quality photos with name and address label on back. All photos will be returned to you upon check-in.

## Selection Process

Entry deadline is March 24. The following items will **NOT** be permitted: crafts made with mostly commercial molds or kits or **food/edible items**. Parks & Rec. reserves the right to request the removal of items deemed unsuitable for the show. For a balanced selection of goods, a limit on the number of exhibitors with similar items will be made. Therefore, it is important that you send your application in early.

## Space, Display and Booth Fees



Booth size for single and shared space is 7' x 12' (7' depth and 12' across the front); a double space is 12' x 14'. **Exhibitors must stay within their assigned space.** Assignments are made at random, and each location is final. Space locations may be requested but are not guaranteed. Each exhibitor is responsible for setting up their own display and must provide all props, supports and tables. **Tables must be covered to the floor. Electrical cords need to be covered with rubber mats or cord covers. Booth backwall and screens must not exceed 8' in height.**

\*Two exhibitors. Each exhibitor must complete an application form and forms should be sent in together.

The show will be held indoors at the Foothills Mall located 4 miles south of the Knoxville Airport at the junction of the 129 By-Pass and Highway 321 in Maryville, Tennessee. The Mall attracts shoppers from a six-county area.
